Deadline for pre-registration: May 28

1. Check-in one half hour before trial time.
2. Pre-register by Friday, May 28. Send entry fee of \$10 per trial for first entry (additional entries per member are \$6) with the registration form and a copy of a current "State Immunization Record". Late/gate entries will be \$12.00.
3. Make checks payable to "Sedgwick Co. Extension" and mail to:

4. Dogs must be at least 12 months of age at date of trial to enter.
5. Dogs in pre-agility will be on leash. Agility I, II, III will be off leash and should be showing in novice or advanced obedience classes.
6. No dog in season will be allowed to show and will be asked to leave.
7. Any abuse of dogs on the show grounds or in the ring will result in disqualification.
8. Any dog fouling the ring will receive a white ribbon.
9. Any dog that is overly aggressive or potentially dangerous to people or other dogs will be disqualified and asked to leave the show grounds.
10. Good sportsmanship shall be observed at all times. The Judge's decision is final. Poor sportsmanship may lead to loss of ribbon, class dismissal or disqualification from the show as determined by the Judge and/or show committee. Any protest should be made in writing to the show committee.
11. Show rules will follow the guidelines of the Kansas 4H Dog Show Rules revised 2021
<https://bookstore.ksre.ksu.edu/pubs/4H1120.pdf>. All dogs must be on leash or in a dog kennel at all times when not in the agility ring.
12. Sedgwick Co. Extension Center will not be responsible for any harm or injury to a dog or person during the show.
